1. Prior to FY 2016/17, Local Law Enforcement entities were reimbursed through a claim process in accordance with existing MOU with OC Probation. Clarification was received from the State allowing for the methodology for disbursement of the funds held in the Community Correctional subaccount to be changed. Funds held in the Community Corrections Subaccount are to be treated as an allocation thereby eliminating the claiming process. Distribution of funds anticipated to be made quarterly and coordinated by CEO Budget.
2. Amounts listed for FY 2015/16 include carry over unspent amounts from FY 2014/15 and reconciled to the General Ledger as of FY 2015/16, June Period 13 Final. No claims processed in FY 2016/17.
3. Allocation for FY 2016-17 Local Law Enforcement approved by CCP Committee on January 21, 2016. Distribution by entity received from Garden Grove Police Department as of July 28, 2016.








Revocations

2016 YTD = 953




Day Reporting Center Participants

Mandatory Supervision (MS)





According to the National Institute on Health (NIH), intellectual disability refers to a group of disorders characterized by a limited mental capacity and difficulty with adaptive behaviors such as managing money, schedules and routines, or social interactions. Intellectual disability originates before the age of 18 and may result from physical causes, such as autism or cerebral palsy or from nonphysical causes, such as lack of stimulation and adult responsiveness.

The presenters will provide guidelines of assistance, services, and accommodations available in Orange County for individuals who may be affected by an intellectual disability.
