Registrar of Voters Achieves Election Success Board Swears-In New Fourth District Supervisor

The Registrar of Voters (ROV) would like to thank the 180 employees and nearly 5,000 volunteers who helped make the June 8th statewide Primary Election a success.

The department's efforts to prepare, including specialized training for poll workers and doubling community outreach efforts to recruit volunteers, helped operations run smoothly on election night. "The election went very well," said Registrar of Voters Neal Kelley. "We were the first of counties with a population over 100,000 to finish precinct reporting on Election Night as well as the first to certify the results by June 22nd."

In line with this notable series of firsts, June 8th was also the first time the ROV increased efficiency using a moving conveyor to sort supplies, including the 482,708 ballots both mailed in and cast in person at 1,104 polling places throughout Orange County.

Election winners of local contests include Shawn Nelson, who received the highest number of votes in the June 8th election for Fourth District Supervisor, thus enabling him to serve the remaining months of former Supervisor Chris Norby's term. Nelson will be the incumbent candidate for a full term of office in the November General Election.

Supervisor Nelson was sworn in by Clerk of the Board Darlene Bloom at the June 22nd Board Meeting with his wife and three children at his side. Supervisor Nelson then immediately joined the Board, marking the first time in five months that the Board of Supervisors has consisted of all five supervisorial districts. The Fourth District represents the cities of Anaheim, Buena Park, Fullerton, La Habra and Placentia.

Other countywide election winners include Second District Supervisor John M.W. Moorlach, Fifth District Supervisor Pat Bates, Assessor Webster Guillory, Auditor-Controller David Sundstrom, Clerk-Recorder Tom Daly, District Attorney Tony Rackauckas, Public Administrator/Public Guardian John Williams and Sheriff-Coroner Sandra Hutchens.

Supervisors Approve \$5.5 Billion Budget

July First marked the start of a new Fiscal Year for the County of Orange, with a \$5.5 billion budget in place for 2010-11. The Board of Supervisors approved the budget during their meeting on June 29th, charting a financial course for agencies and departments to follow in the year ahead.

While the new budget did include significant reductions related to a decrease in property tax revenue and lower sales tax revenue, the budget did not include any employee layoffs. Still to be determined (Continued on page 3)

are the potential impact of actions to be taken by the State of California to produce a balanced budget, with several budget proposals still under consideration in Sacramento. State funding is a significant revenue component for social service and health care programs on the County level.

Of the total budget, the County has the most flexibility with the portion of the budget known as General Fund Net County Cost, which amounts to \$686 million for the new fiscal year. Of that amount, approximately 50% is allocated for Public Protection programs and 22.5% will support Community Services programs.

In approving the new budget, the Board also extended the resolution authorizing elected officials to donate 5% of their salary back to the County and reducing the pay of executive managers by 5%. These actions, taken in recognition of the ongoing County's financial challenges, saved about \$600,000 during the 09-10 fiscal year.

New Director, New Programs for OC Animal Care

After a year as the organization's Interim Director, Ryan Drabek has been named Director of OC Animal Care while the organization moves forward with new programs designed to increase pet adoptions and encourage responsible pet ownership.

Drabek started with OC Animal Care in September 2001 as an Animal Control Officer and served as a Public Education Officer and Program Supervisor for Field Services and Community Outreach prior to becoming Interim Director in May 2009. "I benefitted from 'growing up' in the organization and feel I have a good knowledge base of our services and programs," said Drabek, who is building upon the organization's past successes. Summertime is a busy time for OC Animal Care,



with many special events planned to place available animals in permanent homes. A June Pet Fair resulted in 81 adoptions and OC Animal Care is again partnering with the Los Angeles Angels of Anaheim for the "Angels for Animals' event on July 17th. Coming on the heels of the baseball All-Star Game in Anaheim, Drabek hopes this year's "Angels for Animals" event will exceed last year total of 126 adoptions. The "Angels for Animals" program covers the cost of adoption and needed vaccinations, so new adoptive owners only pay for microchipping and licensing of the pet – a great deal for new owners and for OC Animal Care!

A major success for OC Animal Care this year has been a license amnesty program authorized as a pilot project by the Board of Supervisors. "We sold almost 7,000 more licenses during that 45 day period than the previous year," Drabek noted. The additional revenue helps decrease the financial burden on the County and contract cities while increasing the chances that a lost pet will be reunited with its owner through the license information.

While a new animal shelter continues to be a major goal for OC Animal Care, Drabek and his staff have been working hard to improve relationships with community groups and other animal shelters in Orange County. This broader approach to outreach and a continued focus on customer service are keys to the future success of OC Animal Care. "Our successes are 100% attributed to our dedicated, caring staff," Drabek stated.

Eco-Friendly County Programs Commended by Grand Jury

Three County of Orange departments were lauded by the Grand Jury last month for their commitment to protecting natural resources and employing environmentally conscious practices. In a report titled "Orange County Goes Green," the Grand Jury described the OC Waste & Recycling department as "one of the most costconscious agencies in the county – and one of the most respected in the nation."

The report praised **OC Waste & Recycling's** ability to capture methane gas from the County's Frank R. Bowerman Landfill, convert it into liquid natural gas, and then sell it to power local bus and truck fleets. In addition, the department puts forth tremendous effort to protect the natural environment in its management of the County's landfills, manages four Household Hazardous Waste Collection Centers and has successfully increased the diversion of selfhauled waste from the landfills by 70% through recycling outreach and the self-hauled waste surcharge.

The **County Executive Office's Procurement Department** was also noted in the Grand Jury report for the development of the OC Green Fair, inspired by the Board of Supervisors' adoption of an Environmentally Preferable Purchasing Policy. The purchasing policy sets

forth guidelines for County agencies and departments to ascertain goods and services that are eco-friendly compared to other competing products.

The environmental stewardship efforts of **John Wayne Airport** were also acclaimed in the report including the early implementation of water conservation, pollution prevention, energy efficiency, air quality, noise abatement and recycling practices. This is illustrated through the Airport's requirement of all fleet vehicles, such as taxi cabs and parking shuttles, to use compressed natural gas. Aircraft at JWA have decreased their fuel costs and substantially reduced carbon emissions by using ground-based electrical power for cooling aircraft, rather than onboard auxiliary power units when they are parked at the gate. In addition, almost half of the refuse collected from aircraft and facilities is recycled and all used fuel, oil and solvents are re-used.

"These County Departments have demonstrated innovation by developing environmentally sustainable practices and policies so that we can remain conscientious stewards of our great county for many generations to come," said Board Chair Janet Nguyen.

Sunset Magazine Spotlights Beauty of Upper Newport Bay



Get the 411 On OC Assessor Department

- 1. The Assessor Department determines the taxable value of over 1 million units of property in Orange County every year. The total assessed value for 2009 is about \$419 billion.
- 2. Assessor appraisal and audit staff are certified by the state and trained to appraise many types of property including tract homes, oceanfront estates, condominiums, apartment buildings, hotels, timeshares, sports and entertainment venues, retail centers, office towers, golf courses, cemeteries, historic properties, agricultural and vacant land, business personal property, marine and aircraft, mobile homes, mobile home parks and more.
- 3. The Department reviews about 400,000 documents each year (mostly deeds, trusts, contracts, building permits and tract maps), to adjust values in accordance with Prop. 13, to track the ownership of property, and to adjust land base records and revise parcel maps when property is sub-divided.
- 4. The Assessor collaborated with county assessors and industry statewide in 2004 to develop and launch the first statewide business property e-Filing system. This is a shared-service among 40 of California's 58 county assessors. The system is managed by the Orange County Assessor and is operated from the County's Data Center. Many Fortune 500 corporations and thousands of small businesses statewide use this system to file their business property reports, saving businesses and assessors thousands of dollars in annual costs.
