

**COUNTY OF ORANGE
FIRST AMENDMENT TO AGREEMENT FOR THE
EMPLOYMENT OF COUNTY COUNSEL**

This First Amendment to the Agreement for the Employment of County Counsel ("FIRST AMENDMENT") is made by and between the County of Orange and its Board of Supervisors (collectively, "COUNTY") and LEON J. PAGE (hereinafter "PAGE").

ARTICLE I. RECITALS

- 1.1 WHEREAS, on July 21, 2015, the Orange County Board of Supervisors ("BOARD") approved the Agreement for the Employment of County Counsel ("AGREEMENT");
- 1.2 WHEREAS, the EXPIRATION DATE of the AGREEMENT is July 23, 2019;
- 1.3 WHEREAS, the Board has determined that PAGE'S performance as County Counsel has to date been satisfactory.


ARTICLE II. TERMS

NOW, THEREFORE, in consideration of the mutual covenants, representations, and promises set forth herein, the parties agree as follows:

- 2.1 Except as modified in this FIRST AMENDMENT, all terms of the AGREEMENT shall remain in full force and effect; and
- 2.2 With respect to Section 2 of the AGREEMENT, and in accordance with Government Code section 27641, the EXPIRATION DATE of the AGREEMENT is hereby extended to Monday, May 9, 2022.
- 2.3 With respect to Section 6 of the AGREEMENT, PAGE shall be compensated by the COUNTY on a salary basis through the EXPIRATION DATE of the AGREEMENT, as amended, in the annual amount of two hundred and thirty six thousand dollars (\$236,000), and shall additionally be entitled to receive the same salary adjustments and benefits generally provided to other Executive Management (Group II) employees.

ARTICLE III. ACKNOWLEDGMENT AND CONSENT

By signing below, PAGE and Orange County Board of Supervisors Chairman Andrew Do, on behalf of the COUNTY, each acknowledge that they (1) have read and fully understand the terms and conditions of this AGREEMENT, and (2) consent and agree to each and every term and condition contained herein.
