### **Effective Thursday, December 30 at 1 p.m.: All Evacuation Warnings Lifted for Canyons in Bond Fire Burn Area**

**Santa Ana, Calif. (December 30, 2021):** Effective Thursday, December 30, 2021, at 1 p.m. all evacuation orders will be lifted for Silverado Canyon, Williams Canyon and Modjeska Canyon in the Bond Fire burn area. Road closures will be lifted for all roadways in the Canyons at 1 p.m.

To report storm-related issues with a County road or flood control channel, call the Orange County Public Works Storm Center [714-955-0200](tel:714-955-0200) during standard business hours and [714-955-0333](tel:714-955-0333) during flash flood events and emergencies when OC Public Works' Department Operations Center is activated.
