## FOURTH AMENDMENT TO EMPLOYMENT AGREEMENT FOR EXECUTIVE DIRECTOR OF THE CAMPAIGN FINANCE AND ETHICS COMMISSION

This FOURTH Amendment ("FOURTH AMENDMENT") to the Employment Agreement ("AGREEMENT") for the Executive Director of the Campaign Finance and Ethics Commission is made by and between the County of Orange ("COUNTY") and Denah Hoard (hereinafter "HOARD"). The COUNTY and HOARD shall collectively be referred to herein as the "Parties."

- 1.2 WHEREAS, by minute order dated September 11, 2018, the BOARD approved the First Amendment to the AGREEMENT to modify the compensation, benefits, and annual leave under the AGREEMENT;
- 1.3 WHEREAS, by minute order dated April 28, 2020, the BOARD approved the Second Amendment to the AGREEMENT to modify the benefits under the AGREEMENT;
- 1.4 WHEREAS, by minute order dated March 23, 2021 the Board approved the Third Amendment to the AGREEMENT to modify the compensation and extend the term of the AGREEMENT;
- 1.5 WHEREAS, the BOARD has determined that effective April 7, 2023, the terms of the AGREEMENT should be modified as follows:

## ARTICLE II. TERMS

NOW THEREFORE, in consideration of the mutual covenants, representations, and promises set forth herein, the parties agree as follows:

- 2.1 Except as modified in this FOURTH AMENDMENT, all terms of the AGREEMENT shall remain in full force and effect:
